## High Performance Criteria

Deadline: November 7, 2016

The goal of the Saskatchewan Hunter Jumper Association is to provide a strong support system for riders interested in the sport of showing jumpers and hunters. To enable and to encourage all riders to compete at horse shows where hunter and jumper competitions are available. In order to achieve these goals the SHJA will provide education, support horse shows, and offer clinicians to all levels of hunter and jumper riders in Saskatchewan.

In the spirit of our mission statement the SHJA is pleased to offer the following criteria for competitive riders throughout the province:

- ✓ Canadian Citizen
- ✓ Current Equine Canada Sport License holder
- ✓ Current individual member of Saskatchewan Horse Federation
- ✓ Current member of Saskatchewan Hunter Jumper Association
- ✓ Currently a Junior or Adult Amateur competitor. Juniors may take precedence over Adult Amateurs if all other criteria are equal. Full time professionals are not eligible unless they are riding their own horse and competing as a serious athlete in their own right. Such situations will need to be scrutinized and justified individually as the situation arises.
- ✓ Participation and all placings in EC hunter jumper shows in Saskatchewan and or out of province.
- ✓ Competitor with placing in Equine Canada jumper events 1.10M and above to have consideration before 3′ 6″ hunter events. Should there not be four riders to qualify under the jumper category consideration may be given to the hunter competing at 3′ 6″ ...
- ✓ Be good ambassadors for Saskatchewan and the Saskatchewan Horse Federation and SHJA—behaviour and conduct that is befitting of athletes representing this province.

If you feel you meet the above criteria please submit the following application: including a riding resume from the past twelve months (including supporting receipts), and an annual training, coaching, and competition plan for your horse rider combination for the coming year.
